Course Description: The first part of the intermediate microeconomic sequence is a formal and rigorous introduction to the core microeconomic concepts. These include consumer theory and the derivation of demands, producer theory, and analysis of equilibria in competitive and monopolistic markets. The course will make heavy use of differential calculus.

Textbook:

The textbook for this course is Microeconomics by Besanko and Braeutigam (6th edition), but you can use any other intermediate micro textbook for reference.

Weekly Homework: Each week, I will post practice problems on Canvas. They will not be graded. The best way to prepare for the exams is to form study groups, work on the problems on your own in the beginning and then go over the problem sets together. It is essential that you practice solving these questions. Reading the solutions will not prepare you for the exams.

Easter Egg: I planted an intentional mistake into the solution of one of the problems in one of the problem sets. This is a significant conceptual error and not a typo. The first student to find this mistake, successfully explain why the solution is wrong, and offer the correct solution during my office hours will have their score for the final exam multiplied by 1.2.

Exams: Grading will be based two midterms (30% each) and a final examination (40%). The final exam will be cumulative. You must take both midterms. The dates for the midterms are April 27th and May 18th. The final exam is Friday, 06/09, at 9am. There is no alternative date for the final exam. All exams are closed book, and you may not use calculators.

If you would like to study with other students in this class, consider joining a <u>Peer-Guided Study</u> <u>Group.</u> Participants will meet weekly with about 5 to 8 other students and a peer facilitator, a student who has already taken and done well in the course.
